



Lab Activities

Agritechnology: The laboratory activities (shops, wet labs, land labs, and greenhouses) are an integral part of this program, which includes the safe use and application of high technology equipment, such as computers and computer software, telecommunications equipment, and scientific testing and observation equipment, as well as mechanics' tools, field tools, carpentry tools, arc welders, oxyacetylene torches, tractors and field equipment, chemical applicators, power sprayers, irrigation equipment, and fire-control hand equipment.

Special Note

FFA is the appropriate Career Student Organization for providing leadership training and for reinforcing specific vocational skills. Career Student Organizations, when provided, shall be an integral part of the vocational instructional program.

Safety

It is very important that safety rules and regulations be following in all areas of the Agriscience Department. Including the wearing of closed toed, closed back shoes always. Students must wear long pants for any work in the shop, land lab, etc. Safety issues will be dealt with and may lead to dismissal from the program. Students failing to adhere to the program dress code will be sent to In School Suspension for that period only. Unless, it is a constant, reaccuruing issue.

Class Fees

A \$50.00 Ag Fee is assessed to all students, to help defray the costs of the program. There may be opportunities to "work off" the Ag Fee, during non-school hours. Fees not paid during the 1st nine weeks will be issued a note of obligation and must be paid in order to participate in any school activities.

Behavior

Given the nature of the program and equipment use by the students, absolutely no innapropriate behavior will be tolerated. Such behavior may lead to removal from the program.

"1's"

If your student receives a temporary grade of a "1", this means they missed the work and/or did not turn the work in on time. Those assignments given the grade of a "1", they will be given time to make up the work and will receive lesser credit. If the work is not made up by the announced date, they will be given the zero "0", they earned.
